Twenty percent of children in the United States live with someone with a substance use issue. Yet, those children are often misunderstood and dismissed as resilient. This presentation will take a deeper dive into exploring the impact of parental substance use on children. More specifically, this presentation will outline what the research presents around outcomes and the social, emotional, and physiological risk to children. Protective factors and strategies that can minimize the risk factors associated with this family dynamic will be discussed.
